1 AN ACT concerning

2 Condominiums – Responsibility for Property Insurance Deductibles

- FOR the purpose of altering, in the case of a council of unit owners' responsibility to repair
 damage to or replace certain portions of a condominium, the circumstances under
 which the council of unit owners' property insurance deductible is a common expense;
 increasing the maximum amount of the council of unit owners' property insurance
 deductible for which a unit owner is responsible under certain circumstances;
 making a conforming change; providing for the application of this Act; and generally
 relating to the responsibility for property insurance deductibles in condominiums.

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 16 That the Laws of Maryland read as follows:

1 elements shall be used to restore the damaged area to a condition compatible with the 2 remainder of the condominium;

3 (ii) The insurance proceeds attributable to units and limited 4 common elements which are not rebuilt shall be distributed to the owners of those units 5 and the owners of the units to which those limited common elements were assigned; and

6 (iii) The remainder of the proceeds shall be distributed to all the unit 7 owners in proportion to their percentage interest in the common elements.

8 (4) If the unit owners vote not to rebuild any unit, that unit's entire 9 common element interest, votes in the council of unit owners, and common expense liability 10 are automatically reallocated upon the vote as if the unit had been condemned under § 11 11–112 of this title, and the council of unit owners promptly shall prepare, execute, and 12 record an amendment to the declaration reflecting the reallocations. Notwithstanding the 13 provisions of this subsection, § 11–123 of this title governs the distribution of insurance 14 proceeds if the condominium is terminated.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply to all 16 policies of property and casualty insurance issued, delivered, or renewed in the State to a 17 condominium council of unit owners as required under § 1–114 of the Real Property Article 18 on or after October 1, 2020.

19 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 20 October 1, 2020.
